The Constitution

As of 6 March 2014 this Constitution supersedes all previous issues.

1	<p>The club is called the Wessex Hang Gliding and Paragliding Club. It is registered with the British Hang Gliding and Paragliding Association (BHPA) as a recreational and coaching club. The aims of the club are to:</p> <ul style="list-style-type: none"> • Provide for the interests of hang glider and paraglider pilots in Wessex, • Negotiate and administer flying rights and sites in Wessex for the benefit of members, making sites open where possible or negotiating reciprocal arrangements between clubs, • Build a fund to support acquisition of new sites for the benefit of the UK free-flying community, • Promote excellence in the sport through coaching and by encouraging development for all members at all levels of achievement.
2	<p>The Constitution forms the rules of the club. All members and Committee members are bound by the Constitution.</p>
3	<p>Membership of the Club is open to anyone on payment of the annual or life subscription, regardless of age, gender, disability, ethnicity, nationality, sexual orientation, religion or other beliefs. Flying members must be qualified to BHPA Club Pilot level (minimum, or equivalent) and be a member of the BHPA.</p>
4	<p>If a member of the club has a commercial interest in Hang Gliding or Paragliding they must declare that interest to all members.</p>
5	<p>The Committee may refuse, suspend or terminate membership for conduct considered to be against the best interests of the Club. The decision shall require a unanimous vote by the Executive Committee.</p>
6	<p>The membership year runs from March to February. Membership will automatically lapse if annual subscriptions are not paid by 30 April.</p>
7	<p>An Annual General Meeting (AGM) will be held in March of each year to set the annual subscription, elect a Committee and receive proposals from members. The date of the AGM will be published on the Club web site at least one month before the date of the meeting and individual members will be notified by email.</p>
8	<p>An Extraordinary General Meeting (EGM) may be called by the Committee or by a petition supported by at least 25% of the membership. At least 21 days notice must be given to the membership of an EGM.</p>
9	<p>The Constitution may only be changed at the AGM or at an EGM. An EGM also has the power to change the membership of the Committee.</p>
10	<p>Proposals for consideration at the AGM must reach the Secretary at least 21 days before the date of the meeting. Proposals to either the AGM or an EGM must carry the names of the members proposing and seconding the motion.</p>
11	<p>Proposals will be voted on at the AGM or an EGM and must achieve a simple majority amongst the members present. The Chairman shall have a casting vote in the event of an equal division of votes.</p>

12	<p>The club shall be managed by a Committee elected from the membership. It shall comprise Executive Officers as required by the BHPA plus the Treasurer, and non-Executive Members that the club votes into office. All Committee members may vote at Committee meetings.</p> <p>(See Appendix A for list of Executive Committee roles.)</p>
13	<p>Committee members shall benefit from free membership of the club during the period of their office.</p>
14	<p>The Committee shall aim to meet at least twice a year. More than 50% of the Committee, including at least two Executive Officers, must be present to constitute a valid meeting.</p>
15	<p>All members of the Committee shall retire annually at the AGM but may stand for re-election provided that they remain members of the Club. An Executive Officer may not serve in the same post for more than five successive years.</p>
16	<p>The Executive Officers are Trustees of the Club for the term of their office and act on behalf of the Club. They are responsible for the signing of all agreements or contracts made on behalf of the club. They shall acquaint the members of the of the terms of any such agreement or contract.</p>
17	<p>The Treasurer shall provide abbreviated accounts and bank statements to the Committee every quarter. The accounts of the club shall be audited annually by a person appointed by the Committee. A full statement of the Club's financial standing for the year to 31st January shall be submitted to and approved by the members present at the AGM.</p>
18	<p>Club flying activities are undertaken in accordance with UK Air Law as promulgated by the BHPA and entirely at the member's own risk. Neither the Club nor any of its Officers are liable for material damage or personal injury resulting from member's decisions.</p>
19	<p>Club activities will otherwise be carried out in accordance with relevant legislation including the Data Protection Act and the Equality Act.</p>
